COMES NOW the Iowa Accountancy Examiners Board ("Board") and Darren Bogaards ("Applicant"), on 5/8/2024 and enter into this Consent Agreement for the issuance of a permanent Iowa Accountancy license subject to the following conditions:

A. JURISDICTION AND BACKGROUND

1. Applicant is hereby granted Iowa license no. 014584.
2. On 5/19/23, Applicant submitted a renewal application for a permanent Iowa Accountancy license.
3. Applicant was short by 1 credit hour for the required CPE hours for the reporting period of December 1, 2020 to November 30, 2023.

B. STIPULATIONS

4. **PRACTICE RESTRICTION:** Applicant's license to practice Accountancy in Iowa is continued. Applicant must complete additional CPE hours double the amount they are short, for a total of 2 CPE hours as well as pay a \$250 civil penalty.
5. In stipulating to this Consent Agreement, the Applicant acknowledges the following:
 - a. This Consent Agreement is subject to the approval of the Board and will have no force or effect if it is not accepted by the Board.
 - b. The Assistant Attorney General will present this Consent Agreement to the Board

ex parte.

c. I understand I have an opportunity to be heard and to contest the allegations against me in a formal hearing before the Board and that by waiving the formal hearing, I waive my right to challenge the allegations against me and all attendant rights, including the right to seek judicial review of the Board's actions or to object to the terms of this Consent Agreement.

d. I waive my ability to review the investigative file in this case.

e. I understand this Consent Agreement will be part of my permanent licensure file and may be considered by the Board in determining the nature and severity of any disciplinary action to be imposed in the event of any future violations.

f. I am voluntarily entering into this Consent Agreement.

g. Failure to comply with the provisions of this Consent Agreement shall be grounds for disciplinary action pursuant to Iowa Code § 272C.3(2)(a).

i. I have the right to be represented by counsel in this matter.

j. I understand that this Consent Agreement constitutes formal disciplinary action against my Iowa Accountancy license.

k. I understand I am responsible for all expenses incurred to comply with the conditions and requirements of this Consent Agreement.

6. Applicant shall obey all federal, state, and local laws, and all rules governing the practice of Accountancy in Iowa.

7. Respondent shall submit a copy of this Consent Agreement to all licensing boards where the Respondent holds a license, whether active or not, within **THIRTY days** of the date of the Board approval of this Consent Agreement.

8. This Consent Agreement becomes a public record available for inspection and copying upon execution in accordance with the requirements of Iowa Code Chapters 17A, 22 and 272C.


9. The Board's approval of this Consent Agreement shall constitute a **FINAL ORDER** of the Board.


